As a student enrolled in the TEEN Virtual Academy, I agree to the following:

1. I understand it is my responsibility to promote academic integrity and hereby promise to complete my own schoolwork using my own effort and abilities. As a parent/guardian of a child who is enrolling in the TEEN Virtual Academy, I agree to the terms and conditions of the Student Contract, and I have read and understand the following Parent/Guardian Contract:

1. I understand the importance of supporting my child's effort to maintain academic integrity in regards to completing assignments, projects, papers, and exams online. I will not provide unethical academic assistance to my child, but will provide learning support by monitoring his or her online efforts to complete assignments, projects, papers, and exams in an honest and ethical manner. I understand that any violation of academic integrity will result in disciplinary action, and may be grounds for dismissal from the program.

2. I understand that it is my responsibility to provide and pay an Internet Service Provider (ISP) for a high-speed connection to the Internet. If my home internet gets disconnected, I will find a place for my student to continue to work on classes.

3. I understand that I must maintain an email address for school communication and that my child(ren) must also have email account for communication with their teachers. A student email account will be provided.

5. I am responsible for monitoring my child's class work and study schedule.

6. I understand that my student must be online and working on their courses for 6 hours (excluding breaks and meals) on the set "count days". These two count days will be scheduled by the TEEN Virtual Academy. For Non-Edgenuity courses, I will be required to complete and sign a Student Activity Log and return it to the TEEN Virtual Academy director by September 30. For all courses, I will be required to monitor and supervise my student's work on the count days.

7. I understand that my child may have to report on-site at the district or to a location designated by the TEEN Virtual Academy for all mandated state and local assessments. Information concerning assessments will be sent to parents/guardians.

8. I will read all announcements/calendar items/email and text correspondence and remain up-to-date with events and activities that are available for my child(ren).

9. I will read and reply to emails or other communications from the school within 24 hours of receipt on school days.

10. I understand it is my responsibility to notify the TEEN Virtual Academy immediately in case of any problem with email, logging onto the network, or accessing the curriculum.

11. I understand that TVA/home district is able to view searched content in your home either on a school issued laptop or a personal laptop when logged into the student's district google account.

12. I understand that I am liable for the cost of replacement (including repair) for willfully damaged, lost, or destroyed books, laptop, software, or other property issued me from the TEEN Virtual Academy or my home district. All materials, including the laptop, must be returned at completion and/or withdrawal from the TEEN Virtual Academy. Technology Usage Agreement/Computer Care Contract

1. Never share your passwords. You are accountable for all access to websites, computers, and technology for which you are assigned.
2. Treat all technology with respect. Do not vandalize any technology equipment. Deliberate attempts to degrade the computer networks or to disrupt system performance will result in disciplinary action.
3. Obey rules of copyright, trademark and license restrictions.
4. Avoid any technology activity, which is illegal or involves inappropriate language, pictures, or graphics. E-mail and all other forms of electronic communication are to be used in a responsible manner. Students may not use vulgar, derogatory, or obscene language.
5. Do not give out any personal information, anonymous, or false information on the Internet. Students should consult a parent/guardian if they are in question about sharing any information.
6. Class work is always the priority for virtual program issued computers. Students who are declared absent because of not completing work will be required to return the program issued laptop.
7. Students may not engage in personal attacks or harassment of others, and may not post information about other students or teachers online without their permission.
8. Students will not attempt to install any software, including file sharing programs.
9. Expect all email, files and/or web history to be subject to inspection by the TEEN Virtual Academy/home district. Laptops are filtered for content at your home and content searched is viewable by TVA/home district. School issued Google accounts used on personal computers can also be monitored.
10. Report any inappropriate material immediately to the TEEN Virtual Academy.
11. Students will not use technology and related digital communications to bully, harass, threaten, or discriminate against peers or adults.
12. If a laptop is stolen, it should be reported to the local police through the TEEN Virtual Academy office.
13. Laptops should be protected from food, drink, younger siblings, pets, and extreme temperatures.
14. Students will return their laptop within 30 days of graduating or withdrawing from the program. If the laptop is not returned, it will be considered stolen and the police in your area will be notified.
15. I understand that failure to abide by the components of this agreement may result in suspension or expulsion from the TEEN Virtual Academy. Any violation of these rules will result in disciplinary action.
